## Lot Number or Address

PMROA is requiring lot owners to post their lot number and/or address at the entrance of their driveway or by the road in front of their lot. This is to benefit Emergency Personnel and the County Sheriff's office. PMROA would like this completed by June of 2006.



## Removal of Musk Weed

We have received notification from Summit County that we have a noxious weed growing on our property: MUSK THISTLE. It is a state law that noxious weeds need to be eradicated. The County has passed the same noxious weed act. The reason for such laws are that most noxious weeds take over large areas. Summit County loses approximately 10,000 acres a year to these weeds. The weeds are unsightly and some are poisonous to humans, wildlife and livestock. Please help Summit County to become noxious weed free. With the Utah and Summit County Noxious Weed Act in place, a person can be served papers to control the noxious weeds or eventually fined.



## Snow Plowing Requirements

PMROA is responsible for plowing Tollgate Canyon road from the Freeway to the Gravel Pit. Any additional plowing within the ranch boundaries requires permission from the PMROA. If you intend on plowing to your cabin you need to meet with the PMROA Board prior to plowing. Those individuals that do not meet with the Board beforehand will not be in compliance with the PMROA Rules and Regulations and will face legal action.



## Winter Use of the Gravel Pit

All snow machines need to be kept in the upper part of the gravel pit parking lot. Vehicles are to be parked in the lower parking lot. All vehicles and snow machines require a PMR sticker displayed in plain site (this includes guest vehicles). Any vehicles or snow machines without a sticker will be towed away.



## Winter Roads

During the winter months any vehicles parked on the roads will be towed. Winter driving habits need to be followed within the ranch, many of the roads become icy and very slick. The speed limit through the Ranch is 15 mph. Chains are required when going up Tollgate Canyon Road after the Oil Well turn off.
